NOTICE

Group Medical Insurance Scheme of National Insurance Company Limited for the Retirees of the Bank

Renewal of Insurance Cover w.e.f.: 01.11.2020 Last Date of Submission of Option: 16.10.2020 Date of Debit of Premium : 28.10.2020

We refer to our previous Notice dated 24.09.2020 on the captioned subject.

- In this connection, we may inform you that the National Insurance Company has decided to modify the modalities of the Scheme for Renewal of Group Medical Insurance for the Retirees by introducing a Graded Sum Insured Scheme. They have, accordingly, conveyed new rates of premium for the Base and Super Top-up Policies for renewal of policy for the retirees for the period from 1st November, 2020 to 31st October, 2021 (both days inclusive). Therefore, the rates quoted earlier vide our Circular IOM dated 24.09.2020, hereby, stands withdrawn.
- 3. The rates of premium in the Base Policy and the Super Top-up Policy for renewal of the Group Health Insurance Policy for the retirees for 2020-21 under the newly introduced graded system are as follows:

For base SI 1 lakh, Top up SI will be allowed upto Rs.2 lacs.

For base SI 2 lakhs, Top up SI will be allowed upto Rs.3 lacs.

For base SI 3 lakhs, Top up SI will be allowed upto Rs.4 lacs.

For base SI 4 lakhs, Top up SI will be allowed upto Rs.5 lacs.



- 4. The renewal of the insurance policy will be on the following terms :-
 - Employees, who retired between 01.10.2019 and 30.09.2020, but could not continue the Medical Insurance Scheme by paying one month pro- rata premium for the month of October 2020, for whatever reason, are eligible to join the Group Medical Insurance Scheme for 2020-21.
 - Retirees who are not covered under the Retirees Policy for the year 2019-20 are eligible to join the Group Medical Insurance Scheme for 2020-21.
 - Retirees will be eligible to choose either 'With Domiciliary' or 'Without Domiciliary' option for the Retirees Policy 2020-21, irrespective of the option that they had chosen for the previous year's policy.
 - iv. Retirees who are covered under the existing Retirees' Medical Insurance Policy, but did not opt for Super Top-up Policy in the previous year, will now be eligible to avail the Super Top-up Policy for the year 2020-21. In this regard, it may be noted that the domiciliary hospitalization expenses are not covered under the Super Top-Up Policy.
 - Retirees who stay abroad may submit their renewal application for Medical Insurance Policy for the year 2020-21 via email to star.varisht@bankofindia.co.in.
 - vi. The Competent Authority has accorded approval to credit the pension amount for the month of October 2020 on 28.10.2020 to ease financial burden on retirees. The insurance premium will be debited after crediting the pension amount on 28.10.2020.
 - vii. In view of the ongoing pandemic, the Retirees (superannuated /VRS /CRS) shall electronically transmit through e-mail, the scanned copies of their duly filled- in renewal application forms (Annexure-I) to the e-mail address of the nearest Zonal Office on or before 16.10.2020. The list of the e-mail addresses of the Zonal Offices are attached in Annexure- II. The Zonal Offices are, hereby, advised to acknowledge the receipt of the application form in each case.
 - viii. Please strictly note that accounts having insufficient balance at the time of debit i.e. on 28.10.2020 shall be treated as EXIT cases and will be deemed withdrawn from the Insurance Policy. Similarly, Retirees whose applications are not received by the Bank within the stipulated date will be deemed as EXIT cases.

- 5. Please strictly note that accounts having insufficient balance at the time of debit i.e. on 28.10.2020 shall be treated as EXIT cases and will be deemed withdrawn from the Insurance Policy. Similarly, Retirees whose applications are not received by the Bank within the stipulated time will be deemed as EXIT cases.
- 6. We wish to bring to your kind notice that Bank acts as an intermediary in providing data to the IBA / Insurance Company. The claims shall be scrutinized / settled by the Insurance Company and Bank has no role in the said process.
